**NOTICE OF INTENTION TO ADOPT A  
CONFLICT OF INTEREST CODE OF THE  
PAUMA VALLEY COMMUNITY SERVICES DISTRICT**

NOTICE IS HEREBY GIVEN that the Board of Directors of the Pauma Valley Community Services District intends to amend the District's Conflict of Interest Code pursuant to Government Code Section 87306.

A conflict of interest code designates those employees, members, officers, and consultants who are subject to the disclosure and disqualification requirements of the code. The District's proposed amendment adopts Cal. Code Regulations, tit. 2, section 18730 as the provisions of the Code, includes new positions that must be designated, deletes positions that manage public investments from the list of designated positions, and revises disclosure categories.

The proposed amended Conflict of Interest Code will be considered by the Board of Directors on September 24, 2018, at 10:00 a.m. at 33129 Cole Grade Road, Pauma Valley, California. Any interested person may be present and comment at the public meeting or may submit written comments concerning the proposed amendment.
